# 2018 Environmental Operation

Water & Waste Water Objectives:

- Northern Pulp tests and submits according to government regulations.
- Northern Pulp maintained compliance in 2017 and expects to continue through 2018:

Mill Effluent Toxicity

**Total Suspended Solids** 

Biochemical Oxygen Demand (BOD)

Dioxins & Furans (results show NPNS dioxin and furan levels are lower than detection limits)

- Continue work on Environmental Assessment/permitting for the new effluent treatment system
- Outline provided regarding design of the Boat Harbour replacement Effluent Treatment Facility (ETF) System
- Explanation of Environmental Effects Monitoring (EEM) requirements. Discussion regarding Plan for upcoming Cycle 8. Northern Pulp has completed seven cycles (each cycle is roughly three years in length). Latest cycle has been uploaded to ETF project website at www.northernpulpfuture.ca
- Continue hydrogeological monitoring at the mill site and newly added test points at the Effluent Treatment Facility System
- Identify impacts of ETF and Oxygen Delignification project on water usage
- Design cooling system to allow for recycle of non-contact cooling water
- Presentation of annual effluent quality

#### Air Objectives:

- RB particulate emissions reduced by a minimum of 75% on all stack tests since the precipitator was installed. Frequency of stack testing for RB has been reduced.
- Discussion regarding consistent improvements in fuel management and power boiler operations which has led to a decrease in PB particulate emissions (hog fuel size, air entrainment, PB grate operation, and PB scrubber operation).

• Presentation of NPRI reported total facility emissions and stack testing summaries for PB and RB.

## Nova Scotia Cap & Trade

Northern Pulp is participating in the NS Cap & Trade Program. There are approximately 20 participants in the program. They make up about 55% of total CO2 emissions for the province. NSPI represents greater than 90% of reported emissions in Nova Scotia.

Northern Pulp represents about 1% of the reported CO equivalents emitted in Nova Scotia -- or approximately 0.5% of the total CO2 emissions for the province.

#### Woodlands

## Vegetation Management Program

- Integrated forest sectors are key economic drivers. Large private companies make up 15% of the sector while Crown lands account for 35% and small private wood owners total 50%
- Update on industry and Northern Pulp's use of newer technology such as Machine Navigational Tools, GPS track log and LIDAR
- Northern Pulps' Nursery briefly detailed. Five million seedlings are planted annually with an additional one million (approximately) sold and provided as donations. Private woodlots saw 2.3 million seedlings planted with 2.2 million on Northern Timber lands; 0.5 million planted on Crown land.

#### Lahey Report

- Review on forest practices and evaluation of market access for private forest owners.
- Update on the Lahey Review provided to CLC members. Bill Lahey appointed to lead the review in September 2017. Final report was to be submitted by February 28, 2018. An extension was provided to April 30, 2018.

# Effluent Treatment Facility Replacement Project and Environmental Assessment Update

Plan to submit Environmental Assessment project registration late summer 2018. The project must be approved prior to commencing construction.

- Fishers groups officially broke off talks in February after four Environmental Assessment consultation meetings.
- Second series of public information sessions will be held in the same format prior to project registration document submission to Nova Scotia Environment.
- Re-evaluation requested by CEAA for consideration of a federal assessment.
